Officer Reports

Superintendent's Report – Garry Johnson – Nothing new to report. Garry passed a tool he recently acquired and asked the group to identify what it was. It was a tool to fix Athearn coupler covers. The following description comes from the Micro Mark website. It is titled Bulls Eye Jig, item # 85315 and sells for \$16.95, but don't forget to include our NMRA discount of 15%.

Drill Jig For Repairing Sagging Couplers On Athearn Cars

Use this 'Bulls Eye' jig to drill an accurate #50 hole in the exact center of the coupler box pin for installation of a cover retaining screw. After drilling, tap the hole and install a #2-56x1/8 round head machine screw to tighten the box lid and eliminate coupler droop. Includes machined brass drill guide, six screws and instructions.

Seven members of the board of Division 9 of the Northcentral Region of the NMRA gathered via Zoom for a regularly scheduled meeting to primarily address the upcoming October Clinic that will be hosted by the Division. Those members were:

A general sentiment of a speeding recovery was made to Joel for his recent medical problems.

Superintendent Garry Johnson called the meeting to order at 2:05 P.M. He reported on a contract with the River Church. They do not believe that a formal contract is necessary. They have estimated a cost of \$300 for the Saturday usage of their facility. Superintendent Johnson will attempt to finalize that figure and details next week.

The central topic of discussion was an email sent today from Rich Mahaney concerning the upcoming clinic. Three attachments were included with the email, which are attached. Rich reported that flyers have been distributed to hobby shops in the Region and that there will be notice of the Clinic in the Hot Box to be published in the next several weeks.

Rich went on to inform that his current work is centered on finalizing presenters for the clinic and preparing a flyer with details concerning layout tours and op sessions. Discussion was made concerning how to assign attendees to op sessions. The plan is to finalize that detail in September or October.

Rich expressed his desire that we have 100 attendees for the Clinic. He felt confident that we should reach between 50 and 70 guests.

Some discussion was carried out concerning the need for member volunteers on the Friday and Saturday of the clinic. On Friday, we will need a member at each location to register attendees as they arrive. It was felt that we will need to be ready to greet attendees by 3:00 P.M. at Jim Glenn's home.

Superintendent Johnson discussed screens for clinic presentations. The current plan is to use sheets taped to the wall. An attempt will be made to see if the Region has screens that we can use.

David Vinci stated that he felt that it was time to pass the publication of the Division Newsletter on to another editor/publisher. He informed the board that he will continue in that role through the end of 2022. The board thanked him for his years of service in that role and wished him good luck in working on his layout in his extra time.

The NMRA NCR Division 9 is hosting a Model Railroad Convention over two days (OCT 28/29, 2022) which will include layout tours, clinics, a special dinner and hopefully some operating session, all of this is over a Friday afternoon through Saturday time frame. The location is in the Kalamazoo and Battle Creek area of Michigan. The Kalamazoo Model Railroad Club will be hosting their annual fall train show and sale on the Sunday (Oct 30) of that weekend if you would like to attend that also. A weekend of railroading activities. Hotel selection in the area is on your own. Registration location(s) on Friday will be announced after you register, registration on Saturday will be at the location where the clinics are being held from 7:30am to 12:30pm. **The Saturday registration location and the clinics will be at a facility called The River Church, which located at 517 Walbridge, in downtown Kalamazoo. The building is northeast of the Kalamazoo Amtrak Station and backs up to the train tracks.**

Oct 29, Saturday, at the River Church, registration from 7:30am to 8:30am and time to visit with other model railroaders. **Free donuts, coffee, and soft drinks!**

Oct 29, Saturday, 8:30am, 9:45am and 11am. 12 clinics will be presented between four different rooms.

Oct 29, Saturday, Lunch on your own. Then more model railroad layout viewing 1:00pm to 4:30pm, maybe operating sessions on Saturday evening.
